- 1. Competition is open to all amateur gardeners, designers, and youth through 6^{th} grade. There is <u>NO FEE</u> to enter an exhibit.
- EMPHASIS IS ON FRESH PLANT MATERIALS. NO ARTIFICIAL PLANT MATERIAL IS PERMITED IN ANY DIVISION. NO MATERIAL on the CGCI CONSERVATION LIST may be used unless home grown.
- 3. More than one entry per class may be made in the HORTICULTURE DIVISION provided each is of a different cultivar, type or color and is correctly labeled. Horticultural classes may be subdivided for judging by cultivar, type, or color.
- 4. Exhibitors in DESIGN DIVISION II are permitted only one entry per class. ALL DESIGNS IN DIVISION II REQUIRE ADVANCE REGISTRATIONS (see Division II Rules).
- 5. Exhibitors shall sign in at the registration area and complete the official entry cards provided at the Show.
- Only Designs, Container Grown entries and Special Exhibits may be placed by exhibitor. All other exhibits will be placed by Committee. Exhibits may be moved by Committee if necessary.
- 7. <u>All exhibits/designs must remain in place until 4 pm Saturday.</u> Exhibits not removed by 5 pm may be discarded.
- 8. AWARDS: The Standard System of Awarding (NGCFSHBRUD, pages 5-7) will be used. Ribbons may be awarded in each class or subclass, IF MERITED: one first (blue), one second (red), one third (yellow) and one or more Honorable Mention (white). JUDGES WILL RECOGNIZE EXHIBITS SCORING 90 AND ABOVE. The Scales of Points for judging shall be taken from the NGCFSHBRUD, pages 129-131.
- 9. NGC Top Awards (NGCFSHBRUD, pages 39-49), as noted in the show schedule, may be awarded to eligible sections and divisions. In horticultural classes, correct botanical names are required for NGC Top Awards. In design classes, four entries in each class must be filled for NGC Top Awards to be placed. Judges must withhold awards if these requirements are not met. Using a 3x5 card, all plant material in the design must be named.
- 10, Sponsoring Clubs, the Lawrence Hutton Community Center and the City of Colton will not be responsible for any damage or loss to show entries, nor injury to person or persons.

SHOW ENTRIES ACCEPTED

- 1. All specimens in this division must be fresh and grown by or in the care of the exhibitor for at least 90 days. All container-grown plants must have been in the possession of the exhibitor for 90 days or longer. Combination plantings must have been growing together for at least 6 weeks.
- 2. All entry forms should include correct botanical names (genus and species); variety and common names are encouraged.
- 3. **EXHIBITORS** to provide clear colorless glass containers (no insignias) for cut horticultural specimens. Containers should be marked on the bottom with the exhibitor's name. Plates will be provided for Section D Eatables.
- 4. Only foliage growing on the stem is permitted (except citrus). Exhibits should not have any foliage below the waterline. Unobtrusive assists (wedges) of fresh plant materials are permitted on cut specimens for optimum show presentation.

 5. Double potting and top dressing are permitted. CONTAINERS

Section A entries are limited to 4 per class. Section B entries are limited to 4 per class. For Division II, Sections A & B, 4 entries in each class MUST be filled for NGC Top Awards to be placed

- All entries in Division II must be the work of one individual exhibitor. Exhibitors may enter more than one design, but only one per class.
- 2. Emphasis is on fresh plant material. Plant material need not have been grown by the exhibitor. Each entry must contain some plant material: either fresh, dried, or fresh and dried. No artificial plant material OR material on the CGCI Conservation list may be used. Only dried materials may be painted or treated. Fruits or vegetables, if cut, must be properly sealed. Scientific and/or common names of plant materials used must be listed on a 3x5 card furnished by the exhibitor.
- 3. Class titles are intended to stimulate the imagination but are not to be taken literally.
- 4. Designs shall be placed by the exhibitor (NGCFSHBRUD, page 190), but may be moved by the Committee, if necessary.
- 5. Only backdrops and/or niches furnished by the Committee are permitted in classes 104 and 106. Drapes, coverings, and underlays are allowed but may not be attached to or behind any provided backdrop and may NOT extend beyond any table edge.
- Creative staging is allowed within the space allotted. Manmade materials, accessories, featured objects and other items are permitted: see pages 79-83 of the NGC Handbook (NGCFSHBRUD).
- 7. Landscapes, scenes and living members of the Animal Kingdom are not permitted. Flags and religious symbols, if used, must be displayed in a respectful and proper manner.
 8. Containers and accessories should be marked with the
